The Lincoln County Commissioners attended the MoDot District 3 County Commissioner Regional Meeting from 9:00 a.m. – 12:00 p.m. on February 14, 2011.

Highway Department-Bruce Wallace and Don Lilley

- Road Inspections are being done after the large snow and repairs are being made.
- Complaints from citizens have been addressed as well as citizens calling to thank highway department for a job well done in handling the snow situation.
- Explanation of how crews are dispensed during a snow storm was given. Graders go into operation when 4 or more inches of snow has fallen.
- Waiting on one more bid for a card reader.
- Bids are needed for calcium chloride, used for dust control; an ad will be placed in the Lincoln County Journal and the Troy Free Press.

Auditor-Deanna Colbert

- Questions were addressed on road and bridge salaries and over time as well as 911.
- Presiding Commissioner Dan Colbert stated to the auditor that a Presidential Declaration of Disaster request has been made. If awarded, these funds would partially reimburse payroll overtime.
