The County Commission convened at 9:00 a.m., pursuant to adjournment on March 1, 2011. Present- Dan Colbert-Presiding Commissioner, Jim Mayes-Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, Rick Wilcockson-County Clerk, Kimberly Ingersoll-Chief Deputy County Clerk, the following proceedings were held:

Pastor John Zellmer of New Hope Baptist Church gave the invocation.

Highway Department-Don Lilley

- A Lincoln County resident hit a trailer being pulled by a highway department truck. An accident claim was filled out as well as a police report. There was no damage to the county property.
- Bills for repairs were given to the commissioners for review and approval.
- Concerns about two culverts on South Chantilly Road were brought to Don Lilley's attention. The road is washing away from the end of the culverts.
- Gravens Road flood gates were discussed. Don Lilley agreed with the need of some type of gate system on the road during a flood.
- There are still two bids out for the gas pump card readers.
- Discussion about the railings on the bridge on Aubuchon Road. Don said the pipeline knocked off the railings, that is why there is only caution tape on the bridge.

Special Services-Kelly Hardcastle

- To date 43 applications have been received so far for the administrative assistant position. Kelly would like to have the interview process done within three weeks. He will provide a job description for the commissioners to review.
- Personnel Policy Handbook-Kelly suggested that meal reimbursement be revised to \$30.00 a day, which will be in line with state allowances.
- Joe Steenbergen from Victor Energy Group gave a presentation on the benefits to the county if solar energy was utilized. The commissioners gave Victor Energy permission to have their engineers look at the Justice Center, jail, and the highway department building, complex 1 and 2 as possible sites for solar panels to be placed on the roofs of said buildings.

Prosecuting Attorney-Leah Askey

- Lincoln County Health Department Car Seat Ordinance-the county declined to implement the ordinance. The commission and P.A. Askey support the ongoing educational effort regarding this matter.
