The County Commission convened at 9:00 a.m., pursuant to adjournment on March 7, 2011. ## Treasurer-Krysti Henke

- Reports were given for the gas tax, sales tax and 911 dispatch collection reports. Discussion followed about sales tax in the county being down by 6.8% through the end of February.
- Bro Bridge money transferred into General Revenue per discussion held previously.
- Discussion about funds being transferred into the Law Enforcement Trust fund and the Sheriff's budget in general took place.

## Auditor-Deanna Colbert

- February 2011 monthly report was given to the commission for review and discussion.
- In the future, Deanna will include in her monthly report the Circuit Courts accounts.
- Separate funds will be established for the recording and disbursement of federal and state grant money.
- A letter of recommendation was presented to the commission for the contract from Huber and Associates pertaining to the emergency purchase of the new server and switch.
- The commission asked for a procedural outline for transferring funds from the Circuit Clerk's budget into General Revenue to be allocated to the drug court program for the hire of a contract worker for the Tracker position. The auditor will work with Judge Burkemper on the proper procedure.

## Recorder of Deeds-Dottie Crenshaw

• A proposal was given to the commission for replacement of the recorders server. The funding is available in the technology fund of the recorder's budget. The commission had no opposition to her moving forward with the purchase of a new server.
