# THE JUNE TERM HELD ON 5<sup>th</sup>. DAY OF JULY 2011

The County Commission convened at 9:07 a.m., pursuant to adjournment on June 28, 2011. Present: Dan Colbert-Presiding Commissioner, Jim Mayes – Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, Rick Wilcockson-County Clerk, the following proceedings were held:

#### **Sheriff: Mike Krigbaum:**

- Gas pumps were discussed along with swipe cards, keys and other housekeeping items.
- ICE Inmates are back in custody, 11 are in house.
- Quill pricing was discussed for office purchasing. The Sheriff will provide a list of items in question for pricing.
- Flooding occurred July 3, 2011 in the jail and caused interior flooding in several sections. County maintenance staff performed cleanup efforts. Damages will be assessed today.
- The following issue has been discussed with the Auditor, feeding inmates and cost of meals. The Sheriff brought up the cost issue. Discussion covered original budget, current budget and meal cost comparison. Prisoner revenue was discussed along with cost and budgeting. The issue will be examined around the September time frame. Medical budget was discussed; Sheriff discussed cost and over budget concerns. The Commission will work with the Sherriff to solve issues. Sheriff has been in discussion with the US Marshall's Office.

### Unfinished/New Business: Commissioner Bass attending other duties.

**Heard Petition to Set Speed Limit – Hobart Road:** Petition to post speed limit, the petition was read aloud. Commissioner Mayes made a motion to set the speed limit at 35 MPH, after the pavement is laid. Presiding Commissioner Colbert second the motion, the ayes carried.

**Reading of petition to vacate a portion of Bufford Road:** Presiding Commissioner Colbert read the petition aloud. The first reading is complete, a hearing will be set for the first Monday in October, and all proceedings will go forward at the expenses of petitioners. The written notices will go out as soon as the Prosecutor has reviewed the documentation.

**Purchasing Manual Discussion and Adoption:** Discussion was held on the Purchasing Manual with Auditor and Treasurer. Commissioner Mayes made a motion to accept the Purchasing Manual; Presiding Commissioner Colbert seconded the motion, the ayes carried. The manual will go to the printer.
