Invocation given by: Brent Campbell, Director of Missions- Twin Rivers Baptist Association

Highway Department: Bruce Wallace and Don Lilley

- General vehicle repair and maintenance were discussed.
- General road, low-water crossings repair, overlay and maintenance were discussed.
- Presiding Commissioner Colbert gave Bruce the response from the Commission to the employee that had requested a raise.

Special Services: Kelly Hardcastle

- Lincoln County Public water and sewer LLC public hearing notice for end of August meeting announcement. Kelly is checking with Troy City Hall for clarification.
- Kelly explained there are tax exempt bonds available to businesses that are planning to expand or for
 new businesses that have been impacted by natural disasters. These bonds would be in reference to the
 2008 floods. Bonds would be available for Lincoln County businesses, once the county is approved.
 Kelly is compiling proper documentation to show the impact the flooding had on the county in order to
 get qualified.
- Go Rail, a lobby group that helps form policy to expand rail systems is requesting declaration of support from the county. The declaration was read by Kelly. Benefits of a rail system were discussed. The possibility of a distribution center on the east side of the county would be greatly enhanced if the China Hub is placed at Lambert Airport.
- The validity of the web poll results can be skewed due to the fact that a person can vote numerous times from the same computer.

County Prosecutor: Leah Askey

- Responses to litigation matters were presented to the Commission
- Draft of maintenance easement, statute language was discussed.
- The possibility of impaneling a grand jury, the benefits and detriments were discussed.
- Restorative Justice Program for adult court has been recently put into place by the Prosecutor's Office. A mediator is hired to solve disputes between the victim and defendant. How application and operating fees that will be charged and cost of the program the program will need to be kept separate in the budget. This will help the Prosecutor's Office keep track of revenue and expenses for requesting grant funds. Mediator fees would be kept separate.
- Credit card policy and depository bids are still being reviewed by the P.A.'s office
- Questions for AG's office have been formulated and with Ms. Hagameier's consent, they have been sent to AG's Office.
- The Commission cancelled the 1:30 appoint with Counsel on Tuesday, August 9, 2011.
