Invocation given by Commissioner Matt Bass.

. **Highway Department**: Bruce Wallace and Don Lilley

- Discussed returning grader to Erb on November 9, 2011.
- The maintenance for Robin Road is completed.
- Gravens Road, MODOT is to raise the stop sign to a higher position. County will consider putting up a Dangerous Intersection sign.
- Commissioner Bass asked about the condition of Giles Road.

Special Services: Kelly Hardcastle

- GM plant officially announced the additional 1,800 jobs coming to the Wentzville plant. Kelly is working with Economic Development leaders from Wentzville to possibly relocate some of the suppliers to the Lincoln County area.
- Kelly is working on securing advertising funding for the LINC program.
- Joe Steenbergen, Syndicated Solar, presented a proposal to the Commissioners regarding solar energy. This would offer the county cost savings on electricity. The commission was presented a letter of commitment, for legal counsel to review.

Maintenance Crew: Sam Clary, Randy Siebert, & Allan Watkins

- General maintenance issues were discussed.
- Reviewed and discussed the janitorial supplies and cleaning bids with the maintenance crew.

Judge Ben Burkemper

- Discussed budget requests for 2012. Judge Burkemper is requesting more funds be made available for parent attorney fees. Currently the county has a contract with two local attorneys, and they are putting in many more hours than they are being compensated for.
- Judge Burkemper proposed that the drug court administrator become a full time county employee with benefits. His proposal is that the remainder of the expenditures for benefits would come out of the drug court funds. The administrator would report to Grace Sinclair, Circuit Clerk. Judge Burkemper will check with Grace to make sure she is open to the arrangement.
