**Sheriff Mike Krigbaum**

- The Sheriff inquired about the status of the permits for hot water tanks in the kitchen of the jail. The commissioners informed him that the situation is taken care of, and the proper permits are in place.
- Budget needs for 2012 were discussed, with the commissioners asking the sheriff if he can break down budget items between and jail and patrol division.
- The concept of a regional jail was discussed. The Sheriff feels it would be of no benefit to the county.

**Dottie Crenshaw, Recorder of Deeds**

- Dottie spoke to the commissioners in regards to record keeping practices of county roads. Also present and giving input was: Bruce Wallace and Don Lilley, Highway Dept; Kelly Hardcastle, Special Services; Kevin Bishop, Assessor; and Deanna Dickmeyer, Auditor. It was decided that a database for the roads would be kept at the highway department. Dottie suggested the commissioners put together a written policy. Kevin will create a map marking all county roads, whether they are paved or gravel, etc.
