The County Commission convened at 9:05 a.m., pursuant to adjournment on February 28, 2012. Present: Dan Colbert-Presiding Commissioner, Jim Mayes – Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, Crystal Hall--County Clerk, the following proceedings were held:

Invocation given by Commissioner Mayes.

Highway Department: Bruce Wallace

- General road maintenance issues were discussed.
- Don Lilley is working with MODOT on gps mapping of the county roads.
- The trash has been cleaned up at the Old Moscow Mills Bridge. The Commission will discuss with the prosecutor to inquire about closing the road and putting up a cable to restrict access to that area due to public safety hazards.
- Commissioner Mayes made a motion to have Mordt Tractor repair the New Holland TS125A tractor. Commissioner Bass seconded the motion. The ayes carried the motion.

Special Services: Kelly Hardcastle

- Kelly presented lease agreements for the Commissioners to sign regarding flood plain properties.
- Discussed the expansion at Bodine Aluminum.
- Kelly reported that the Lincoln County delegates to the TAC board made a lot of good points at the recent board meeting.
- Commissioner Bass asked about Emergency Management in the event of a tornado. Kelly reported that all emergency procedures are in place for dealing with a tornado and that the COAD (Community Organization Active in Disaster) is in place for sheltering citizens should such an event occur. Kelly says the best way to prepare for severe weather is to purchase a NOAA weather radio with SAME technology. Kelly offered that more information regarding preparedness can be obtained at:

Maintenance Crew: Sam Clary, Allan Watkins, and Randy Siebert

- General maintenance issues were discussed.
- Discussed surveillance cameras and lighting at the employee entrance of the Justice Center. Randy will look into a price for concrete structures at the front entrance.
- Discussed purchasing ballasts in bulk for replacement at the courthouse and highway department. The Auditor has found pricing through a state bid, and the purchase order will be put together for stock from Voss.
- Sam is working with Dave Wommack to coordinate the work on the Server Room Upgrade Project. Sam expects the elevator to be down 3-5 days during the project. A plan is being put in place to accommodate citizens while the elevator is unavailable.
- Sam informed the Commissioners that the green benches in the front yard of the Courthouse are in bad shape and need to be replaced.
- Commissioner Colbert asked Sam to put together specifications for the bidding process to replace the 5 oldest air conditioner units.

New Business

Corso Road

Jack Dameron, John Northcutt, and Kenny Brown were present and shared their concerns regarding Corsoo Road with the Commissioners. MODOT will be shutting down a bridge on Hwy E later this year, and there is concern about large trucks using Corso Road as an alternative. They would like the Commission to put up load limit signs on the road, as there are box culverts on the road that would not withstand the weight of the large trucks. The Commissioners will discuss with the Prosecutor to check on the legality of the limit signs.

Leah Askey, Prosecuting Attorney

- George Gundy should have the documents ready this week for the scrivener's error for N. Ethlyn Rd.
- The Commissioners addressed some concerns they have regarding lighting at the employee entrance.
- Discussed the desire of immediately closing the road at the Old Moscow Mills Bridge. The Commission would like to put a cable across the road as a matter of public safety. Leah will look into the matter.
- Weight Limit signs for Corso Road were discussed. Leah says the weight limit signs can be posted at the end of the road, and at the box culverts.
