Invocation given by Commissioner Bass.

Highway Department: Bruce Wallace

- General road maintenance issues were discussed.
- Fabick will give credit towards account for 50% of the cost of new grader tires on the buyback unit. The County will be turning in one grader when the new graders arrive next week.
- A dead end sign will be placed on Royster Road.

LINC Proclamation

• The Commissioners signed a proclamation declaring March 2012 LINC transportation month in Lincoln County. March is the 10th Anniversary of the LINC program in Lincoln County.

911 Communications: Margie Harrell

- 911 Board will be conducting interviews on March 14, 2012 for open dispatch position.
- Margie discussed the Missouri Statewide interoperability plan, and her reasons for not wanting to sign a concurrence approval due to the possibility of bleed-over on the band. Margie will communicate with the Prosecutors office to discuss the contractual obligations of this agreement.
