

## THE APRIL TERM HELD ON THE 3rd DAY OF APRIL 2012

The County Commission convened at 9:05 a.m., pursuant to adjournment on April 2, 2012. Present: Dan Colbert-Presiding Commissioner, Jim Mayes - Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, Crystal Hall-County Clerk, the following proceedings were held:

Invocation given by Commissioner Bass.

**Sheriff Mike Krigbaum**

- Discussed the Jail Improvement Fund. The fund had previously relied on a tax base income which has since expired. Currently there is less than one million dollars in the fund, and discussion was had on options of securing funding for future jail improvements.
- The Sheriff is in need of new patrol cars, the department hasn't replaced vehicles in the fleet since 2009.
- There are currently 111 prisoners in the jail. 11 Marshal prisoners, and 3 ICE.

**Kevin Bishop, Assessor**

- Requested a single feasible source purchase for the mailing of assessment forms from EJ Rice. Kevin will check with his software provider, Vanguard, to see if there are other vendors who provide the same services to try to obtain a quote.
- Gave an update on the server project. Work is to begin on the room April 9, 2012. The server should be built and delivered by April 30, 2012.
- The lease for the Assessors copier will expire in 2013. Kevin would like to lease a newer machine at that time. Discussed leasing options. He will obtain bids later in the year.

**New Business****Award of Calcium Chloride Bids**

- Commissioner Mayes made a motion to accept the bid from Scot Wood Industries for 38% Calcium Chloride at 94.5 cents per gallon. Commissioner Bass seconded. The ayes carried the motion.
- Commissioner Bass made a motion to leave the price for dust-control the same as 2011, at the price of \$1.50 per running foot. Commissioner Mayes seconded. The ayes carried the motion.

**Gary Balkenbush, Iron Planet**

- Commissioner Bass made a motion to list and sell a 2006 CAT backhoe and a 1991 Trail King low boy trailer with an 8% commission rate with Iron Planet. Commissioner Mayes seconded. The ayes carried the motion.
