#### **Highway Department:** Don Lilley

- General road maintenance issues were discussed.
- Commissioner Colbert has prepared a spreadsheet of best pricing from the quarries which were awarded the rock bid to be distributed to all drivers.
- Geeding Construction has completed the pipeline repair work on Hampel Road.
- Discussed the status of right of way agreements for Chantilly Road.
