## **Special Services:** Kelly Hardcastle

- Hardcastle is awaiting a call back from Steve Dodd with BNSF to inquire about rail spurs.
- Discussed recent conversations with Trinity Underground.
- The Commissioners will ask Sam Clary to put new advertisement decals on the LINC bus.

## **Highway Department:** Bruce Wallace

- General road maintenance issues were discussed.
- Roadsafe Traffic Systems has completed striping the roads that were ready at this time. When the ongoing paving projects are completed, Roadsafe will return to complete the striping.
- Reviewed which sections of Elm Tree Road are the County's responsibility, and which are the responsibility of the City of Troy, the City of Moscow Mills, and MoDot.
- Discussed the situation with Blevins Construction concerning the breach of contract with the County. The Commission has mailed a certified letter to Blevins Construction notifying Blevins of the breach of contract.
- Commissioner Bass made a motion that due to unacceptable performance on recent local MoDot projects to pass over Chester Bross Construction, which was the second lowest bidder, for the aggregate seal coat project. Commissioner Mayes second. The ayes carried the motion. The Commission will mail a certified letter to Chester Bross Construction notifying them of their decision.
- Commissioner Bass made a motion to accept the original bid for 3/8 aggregate and award
  the contract pending a preconstruction meeting to Missouri Petroleum for the aggregate
  seal coat project. Commissioner Mayes second. The ayes carried the motion. The
  Commission will mail a certified letter to Missouri Petroleum notifying them of their
  decision.

## **911 Director:** Margie Harrell

- Commissioner Mayes made a motion to follow the recommendation of the 911 Advisory Board and hire Jamie Key and Carrie Steinmeyer for the two open positions in the 911 Center. Commissioner Bass second. The ayes carried the motion.
- Harrell presented copies of the yearly maintenance contract from Centurylink for the Commissioners to review.
