

THE OCTOBER TERM HELD ON THE 30<sup>th</sup> DAY OF OCTOBER 2012

The County Commission convened at 9:05 a.m., pursuant to adjournment on October 29, 2012. Present: Jim Mayes - Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, Crystal Hall—County Clerk, Absent: Dan Colbert-Presiding Commissioner, the following proceedings were held:

Invocation given by Commissioner Mayes.

**Sheriff Mike Krigbaum**

- Presented Commissioners with “Blue Print Safety Program” contracts from MODOT for signatures.
- Presented Commissioners a draft copy of the Memorandum of Understanding for the Lincoln County Regional SWAT team. The Commissioners would like to take the time to review the Memorandum before making a motion to authorize the Sheriff to enter into such an understanding.
- Discussed the need for new patrol cars in 2013.
- The Commissioners will be visiting the jail to look at the tile situation in the showers.

**Crooked Creek NID Petition**

- Barbara Wright and Scott Orf, Trustees for the Crooked Creek subdivision were present to discuss a proposed NID for road improvements in the subdivision. Jay Gourley from Boonslick addressed drainage issues with the roads, and stated he felt the drainage be fixed before the money was spent to fix the road. Gourley states that the NID would not be beneficial to the subdivision or the County based on the amount of money that the Subdivision is requesting for the NID, when you take into consideration the cost of the bonds and fees associated with the NID. He feels the Trustees of the subdivision would be better off to go to a bank to obtain a loan. The Commissioners will review the request for petition regarding the NID and make a ruling in the near future.
- Gourley suggests that the County adopt a policy concerning Neighborhood Improvement Districts.

**New/Unfinished Business**

- Sherry Murphy, Flynn Insurance presented rates for health insurance benefits for 2013. Christine Hawkins from United Health Care and John Ohen and Rita Williams from Coventry each did a presentation of benefits for their respective companies.
- One bid was opened and read aloud for snow plowing. The bid was from Kay’s Snow Removal and the bid was for \$64.00 per hour.
- Two bids were opened and read aloud for Security Services. Custom Security LLC bid \$15.50 per guard per hour at the Justice Center and \$13.00 per guard per hour at the Courthouse. Securitas price was \$17.71 per guard per hour.
