• The minutes from April 29th and April 30th have been reviewed. Commissioner Galloway made a motion to approve the minutes as presented; Commissioner Bass seconded the motion. The ayes carried the motion.

Sheriff John Cottle

- Lift for auto repairs is in and ready to be installed at the County Shed. Sheriff Cottle is getting pricing for compressors.
- Cottle reports there are currently 26 Federal prisoners.
- Discussed the Memorandum of Understanding between the Sheriff, Prosecutor, and Commission regarding electronic monitoring. 90% of the income from the proceeds of monitoring is to be put in the Law Enforcement Trust Fund, with the remaining 10% to go into general revenue towards the prosecutor's budget.
- The Sheriff and Prosecutor have recently met with leaders of the Village of Fountain and Lakes and Chain of Rocks to discuss a potential fee based contract for law enforcement in the small villages.
- Commissioner Galloway made a motion to go into closed session to discuss legal issues. Commissioner Colbert second. A roll call vote was taken, all ayes to enter closed session. Motion carried.
- Commissioner Galloway made a motion to leave closed session. Commissioner Bass second. A roll call vote was taken, all ayes to leave closed session. Motion carried.
