Kristen Burkemper, Treasurer

• Burkemper presented the April and May sales tax reports and April gas tax report. Sales tax is down 4.1% for the year. Gas tax is down 3.5% for the year.

Deanna Dickmeyer, Auditor

- Presented monthly Auditors Report to the Commission. Dickmeyer is communicating with the Collector's office to resolve discrepancies reconciling Collector's receipts from what is entered in the Incode system and what is turned in to the Treasurer.
- Dickmeyer presented a draft she has written for a policy regarding disposal of surplus property.
- Dickmeyer reported on her recent Auditors Training and shared with the Commission some handouts which were discussed at the training.

Public Hearing: Lakeview NID

- A public hearing was held for the purpose of considering the neighborhood improvement district improvements for the Lakeview Subdivision Sewer Project and assessments described in the petition to create said district.
- Commissioner Galloway made a motion to approve an order authorizing project improvements for the Lakeview Subdivision sewer project; approving a preliminary assessment roll; instructing the appropriate County Officials to let the project out for bid; and authorizing certain other actions in connection therewith. Commissioner Bass second. The ayes carried the motion.

- Opened and read aloud bids for a used 4X4 light duty vehicle. Price Gnade Ford quoted 4 vehicles: 2012 Ford Escape with 33,502 miles for \$23,435; 2012 Ford Explorer with 38,109 miles for \$30, 288; 2013 Ford Escape with 568 miles for \$26, 298.

- Open and read aloud bids for striping of roads from the following: Road Safe Traffic System \$725.00 per mile and Zone \$497.11 per mile.
