#### **Highway Department:** Bruce Wallace and Don Lilley

- General maintenance issues were discussed.
- Speed limit signs have been placed in the proper locations on S. Ethlyn Road.
- Wallace will send a crew out to repair a hole at the south side end of the N. Chantilly Road Bridge.
