#### **Economic Development Director:** Larry Tucker

• Tucker presented the Commission an activity report of the meetings he has attended in the past month and discussed the contacts he has made in the County regarding economic development.

### Emergency Management Director: Jerry Daugherty

- Daugherty has sent 2<sup>nd</sup> notice letters regarding four lease properties.
- Discussed mapping license for Kim Biondo, Administrative Assistant. The cost for an additional license is \$1,650.00. Daugherty to put together a purchase order for the license
- Daugherty reported on the March 17, 2014 public hearing concerning the proposed flood plain ordinance. Daugherty requested that the Commission put the issue on next week's agenda for approval of the ordinance.
- Daugherty is working on obtaining the funding from the generator grant.

#### **911 Director:** Margie Harrell
