• Presented tax affidavits from April for the Commissioners to sign.

Maintenance Staff: Randy Siebert

- General maintenance issues and work orders were discussed.
- Discussed warranty work recently completed at the jail by Integrity Steel Works.
- Siebert will contact Area to discuss cleaning products leaving a sticky residue on tile floors at the Justice Center.
- Discussed storage space at the Justice Center basement and the available offsite storage space. Siebert will coordinate with Grace Sinclair to move files to the offsite storage if possible.

911 Director: Margie Harrell

- Harrell states that all equipment is back up and running at the center after the April lightning strike. Some replacement equipment is still in route, but the center functions thanks to borrowed equipment from vendors until the replacement equipment arrives.
- Tiffany Hockerson has given her notice June 1st will be her last day. Harrell will search through the recent pool of applicants to hire a replacement dispatcher.
