#### **Sheriff John Cottle**

- There are currently 150 inmates in the County jail, of which 30 are ICE and 29 federal. The jail is preparing meals at .80 per meal per inmate.
- The Sheriff is sending the Sprinter vans to a diesel mechanic for inspection.
- Discussed recent seizures made by the task force. \$400,000 in seizures were made in a two day period.
- Discussed maintenance at the jail. Sheriff Cottle is very pleased with the work performance of Clay Stewart.

#### **911 Director:** Margie Harrell

- Interviews will be conducted at the next 911 Board meeting for the open dispatch position.
- Grace Swank has resigned from the Center. Margie Harrell has requested that we hire 2 dispatchers from next week's round of interviews.
- Lisa Goetsch leaves for Maryland next week for training on community education for fire and emergency safety.
- Discussed changing the name of a private lane for mapping and 911.
- Commissioner Bass made a motion to make an emergency procurement for \$17,047.78 from Voice Products, Inc.; \$11,980.00 from A&W Communications, Inc.; and \$36,445.64 from Centurylink all due to the April 27, 2014 lightning strike and replacing 911equipment in the center. Commissioner Galloway second. The ayes carried the motion.
- Commissioner Bass made a motion to go into closed session to discuss personnel matters.
  Commissioner Galloway second. A roll call vote was taken, all ayes to enter closed session. Motion carried.
- Commissioner Bass made a motion to leave closed session. Commissioner Galloway second. A roll call vote was taken, all ayes to leave closed session. Motion carried.
