The County Commission convened at 9:05 a.m., pursuant to adjournment on November 4, 2014. Present: Dan Colbert-Presiding Commissioner, EuGene Galloway- Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, and Crystal Hall, County Clerk, the following proceedings were held:

Invocation given by Commissioner Bass.

Highway Department: Bruce Wallace

- General maintenance issues were discussed.
- Wallace reported of an accident where a motorist struck the Quarry Road Bridge on Sunday, November 9th. The bridge appears to be in good condition. Wallace gave the Commission the accident report number from the Highway Patrol.
- Work is being done to repair the approach to Gravens Road from Cooper Lane.
- Grading has been completed on Old Cap-Au-Gris Road.
- Work continues on the salt structure, wall sealing will be completed later today.
- The bridge deck is scheduled to be poured next week on the Fairview Church Road Bridge.
- Commissioner Bass made a motion to approve a 35mph speed limit on Kitson Road. Commissioner Galloway second. The ayes carried the motion.
- Commissioner Galloway made a motion to approve a 25mph speed limit on Paulsmeyer Road. Commissioner Bass second. The ayes carried the motion.

Unfinished/New Business

• Public Comment: A resident complimented the Commission on the removal of the old trees and the planting of the new trees and shrubs to the Courthouse grounds.

Maintenance Staff: Sam Clary & Randy Siebert

- General maintenance issues and work orders were discussed.
- Randy Siebert presented the Commission information regarding a parts and labor maintenance agreement for the X-ray machine at the Justice Center.
- Siebert has scheduled a rental for a lift and will begin replacing lights at the jail on Wednesday.
- Sam Clary reported that the annual fire extinguisher inspections were completed for the Courthouse and Complex 1 and 2.
- Centurylink replaced the router at the Courthouse.
- Discussed salt and ice melt supply for sidewalks and parking lots. A purchase order will be put together to purchase 8 pallets of rock salt from COOP and 4 pallets of ice melt from R.P. Lumber.

- Commissioner Galloway made a motion to adopt 2015 911 rates as proposed by the 911 Board. Commissioner Bass second. The ayes carried the motion.
- Dustin Berry, SKW presented the Commission with a scope of work and proposal for design and construction inspection services for the Quarry Road Bridge.
- The minutes from October 27th and 28th and November 3rd and 4th 2014 have been reviewed. Commissioner Bass made a motion to approve the minutes as presented. Commissioner Galloway second. The ayes carried the motion.

- Commissioner Galloway made a motion to adopt an addendum and understanding to Lakeview Neighborhood Improvement District wastewater collection system and water system infrastructure development agreement. Commissioner Bass second. The ayes carried the motion.

- Commissioner Bass made a motion to leave closed session. Commissioner Galloway second. A roll call vote was taken, all ayes to leave closed session. Motion carried.
