The County Commission convened at 9:05 a.m., pursuant to adjournment on May 18, 2015. Present: Dan Colbert-Presiding Commissioner, EuGene Galloway- Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, and Crystal Hall County Clerk, the following proceedings were held:

Invocation given by Rev. Gary Jackson.

Emergency Management Director: Jerry Daugherty

- Daugherty is working with crews from the Highway Department to install the generator at the Winfield tower. This will finalize the Tower Power grant project.
- Discussed an invoice from A&W Communications for \$2,531.83 to repair a radio repeater used by dispatch to communicate with Moscow Mills PD. The invoice will be paid out of the EMA budget.
- Daugherty is waiting for an update from Joel Eisenstein concerning the SEMA CAV violations.
- Multiple leased lots expired and were not renewed by Timberlake Marina. These lots will be offered to adjoining landowners for lease if interested.
- Four cabins by the Norton Woods Public Access are in violation with the floodplain ordinance. Daugherty will reach out to the owners to try to rectify the situation.
- Temporary use permits are being issued for 180 days on RV's, campers, and trailers in the regulatory floodway per the County Floodplain Ordinance.
- Daugherty reported that nearly 500 homes were reported damaged during an April storm and discussed the need for a County wide tornado warning siren.
- Discussed the County Credit Card Policy. Daugherty stated he had not previously received a copy of the policy. He has since received a copy of the policy and will return the acknowledgment of such to the County Treasurer.

Barb Wehde, County Auditor

- Discussed the format of the Auditors monthly report to the Commission.
- Wehde has not received any updates from the Department of Justice regarding the Anti-Fraud Policy.
