- Discussed recent issue with generator not starting after an outage. CK Power came out to check it and advised that the power board had gone out. A new board has since been installed. Harrell will train additional staff on how to manually start the generator.
- Discussed upcoming flooring replacement at the center.
- A purchase order has been put in for replacing the portable air conditioner for the server room.
