Board of Equalization

The annual meeting of the Lincoln County Board of Equalization was held.

The board heard the appeal of Danny Mack. Mr. Mack disputes the appraised amount of his home and states that the year built is incorrect and noted that his fireplace is faux brick and not masonry. Kevin Bishop, Assessor explained that in the past the values were based on sketches made by field personnel and if they didn't have access to the entire property some items were missed. With field and aerial photos, these items are now being realized on the assessments, and noted that they are being depreciated based on the year of original construction. Commissioner Galloway made a motion that Kevin Bishop make the changes concerning the original year of construction of the home and adjust for the fireplace; after the recalculation is made, Mr. Mack will have until August 3rd to decide if he wishes to continue his appeal.
