## Economic Development Director: Larry Tucker

- Larry Tucker presented the Commission with an Activity Report, which highlighted economic development for the month of December.
- Tucker gave an update on the Certified Workforce Ready Community efforts. Tucker is working with the IDA and Representative Pietzmann to try to establish a new technical training facility in the County.
- Commissioner Bass made a motion to waive the audit requirement for the Highway 61/State Highway U Transportation Development District. Commissioner Galloway second. The ayes carried the motion.

• Gourley reviewed project list and updated the Commission on status of all projects.

## Jerry Fox, Collector

• Presented tax affidavits from December for the Commissioners to sign.

#### **911 Director:** Margie Harrell

- Discussed Harrell's recent attendance at the RHSOC meeting.
- 911 Advisory meeting is scheduled for January 21, 2016.
- Discussed upcoming training and recertification's for staff in the center.

## **Emergency Management Director:** Emma Epplin-Birdsell

- Commissioner Bass made a motion to award the Lincoln 2015 Flood Damage Contract 1 to Kuesel Excavating for \$132,500.00. Commissioner Galloway second. The ayes carried the motion.
- Commissioner Galloway made a motion to purchase 14 Ford Fusions and 2 Ford Transit Connect cargo vans from Joe Machens Ford utilizing MODOT contract 3-140926TV for \$279,900.00 total. Commissioner Bass second. The ayes carried the motion.
- Commissioner Galloway made a motion to purchase one Chevrolet Express 15 passenger van from Don Brown Chevrolet utilizing state contract# C116024003 for \$28,045.00. Commissioner Bass second. The ayes carried the motion.
- A \$70,000 down payment will be made for the vehicle purchases with the remaining balance to be financed as a lease purchase through Peoples Bank & Trust Company.
