- Gourley reviewed project list and updated the Commission on status of all projects.
- Presented a letter from the Health Department regarding Larry Lumley and the Lakeview NID.
- Provided graphs from 2015 & 2016 of Courthouse Electric & Gas bills, using graphs as a visual for potential savings with the installation of insulation.
- Discussed Cartegraph program for Highway Department. Program will keep track of inventory. Program will contain one domain. The program is available for purchase on a State Contract through SHI. Tablets can input GPS, Materials used (culverts, rock, etc.).

- Commissioner Mueller made a motion to decline recommendation from the 911 Advisory Board to appoint Robert Henebry to the 911 Advisory Board. It is the opinion of the Commission, that as Mayor of Hawk Point, Mr. Henebry is directly associated with municipal police, and thereby not a member of the general public. The open position is for

a member of the general public. Commissioner Bass second. The ayes carried the motion.

To appoint Angie Baker and Chad Witte for the term January 20, 2017 to January 20, 2020. To appoint Darrell Harke to the vacant unexpired term ending January 20, 2019. Commissioner Bass second. The ayes carried the motion.
