**Brenda O'Brien, Treasurer**

- O'Brien presented the Sales and Gas Tax Reports. O'Brien reports that sales tax was up 14.5% for the month and up 11.5% for the year compared to the same period during 2016. Gas tax was up 5.9% for the month and up 5.2% for the year compared to the same period during 2016.
- Discussed equitable sharing funds received by the Prosecutor's Office.

- Jung inquired regarding the process of how to handle selling two different vehicles for wards.
- Discussed posting job opening for hiring a deputy for office.
