## Economic Development Director: Larry Tucker

- Larry Tucker presented the Commission with an Activity Report, which highlighted economic development for the month of March and April.
- Discussed participating in the Elsberry "Feels Like Home Tour".
- Attended the Winfield Pharmacy ribbon cutting ceremony.
- Attended the first quarterly meeting of Elsberry Community Growth Association.
- Participated in the Missouri Farmers Care "Agri-Ready" County designation ceremony.

## **Project Coordinator:** Jay Gourley

- Gourley reviewed project list and updated the Commission on status of all projects.
- 2017 Courthouse Columns restoration is in preliminary planning phase.
- Applying for 2017 TRIM Grant for Justice Center and Highway Department.
- SHPO Grant Contract negotiations have begun.
- Whiteside sewer system project in progress.
- Working on getting bid for dispatch door replacements.

## **Emergency Management Director:** Emma Epplin-Birdsell

- Discussed grant for generator, pending press release.
- Tornado siren grant out to bid soon.
- 2 pending grants for HMPG 4238 and EMPG FY 17. Discussed Hazard Mitigation Low Water Crossings, submitting a new software analysis.
- Administered the annual Nixle phone call.
- In process of rewriting LEOP towards accreditation standard.
- Discussed need to renew MOU with Warren County for Mutual Aid Agreement.
- Updating large maps and brochures.
- Epplin-Birdsell will be attending MOEMA Conference on April 19, and EMAP on May 9<sup>th</sup> and 10<sup>th</sup>.
- Working on creating a volunteer application for assistance in EMA office.

## **Unfinished/New Business**

- Bids were opened and read aloud from the following for the Portable Generator Bids: NuWay – Atlas \$49,695, Gateway Industrial Power – Axsa \$32,675 and Taylor \$33,500, and Pat Kelly Equipment – Generac \$37,962, and \$48,263 (new).
- Commissioner Bass made a motion to award the Portable Generator Bid to Gateway Industrial Power for the Taylor model \$33,500.00. Commissioner Mueller second. The ayes carried the motion.
- C&C Asphalt was the lowest bidder for the 2017 Aggregate Seal Coat Bids; however they did not submit the required mix design or the certification for blending agent and subsequently their bid was declined as it did not meet specifications. Commissioner Mueller made a motion to award the 2017 Aggregate Seal Coat Bid to Missouri Petroleum
