**Brenda O'Brien, Treasurer**

- O'Brien presented the Sales and Gas Tax Reports for the month of June. O'Brien reports that sales tax was down 10.2% for the month but remains up 2.8% for the year compared to the same period during 2016. Gas tax was up .1% for the month and remains up 2.2% for the year compared to the same period during 2016.
- O'Brien has two computer units that need to be disposed of. Commission Mueller made a motion to dispose of the following at county electronic recycling day on August 12, 2017: Apex Pentium PC, Inventory tag #1147; Dell Workstation CPU, Inventory tag #1156. Commissioner Bass second. The ayes carried the motion.

- John Kinion of K. Flynn Insurance, presented the renewal for the property & inland marine insurance policy. Commission Mueller made a motion to renew the contract with K. Flynn Insurance Agency for \$64,173.00 to insure commercial property and inland marine. Commissioner Bass second. The ayes carried the motion.
- Commissioner Bass made a motion to accept the resignation of 911 Advisory Board member, Terry Foster, effective immediately. Commissioner Mueller second. The ayes carried the motion.
- Discussed Highway Department personnel. Commissioner Mueller made a motion to offer position to Austin Kreuger at \$12.50 per hour, and moved to \$13.50 per hour after a 90 day probationary period. Commissioner Bass second. The ayes carried the motion. Commissioner Bass made a motion to increase Charley Ohmes pay to \$13.50 per hour, effective July 1, 2017. Commissioner Mueller second. The ayes carried the motion.
- Commissioner Mueller made a motion to accept a change order from Cannon General Contractors in the amount of \$11,276.70, for adding length to culvert box on Dickerman Road project. Commissioner Bass second. The ayes carried the motion.
