Emma Epplin, Emergency Management Director

- Discussed status of pending grants.
- Established a Standard Operating Procedure (SOP) for road closures, with the Lincoln County Highway Department.
- Discussed the relocating the EOC; the EOC will operate out of Old Monroe Fire Department and Epplin will be submitting for an EMPG grant for purchasing furniture/equipment for the EOC.

- Sheriff Cottle reported the jail is currently housing 102 Marshals & ICE prisoners; 220 total inmates.

- Discussed the progress on construction of the evidence & training building.

O'Brien reports that sales tax was up 32.96% for the month and is up .74% for the year compared to the same period during 2017. Gas tax was up 8.1% for the month and remains up 8.2% for the year compared to the same period during 2017.
