### **Sheriff John Cottle**

- Sheriff Cottle reported the jail is currently housing 96 Marshals & ICE inmates; 196 total.
- Discussed the status of the VoIP system transition between the Sheriff's Dept. and Justice Center; project to be completed by the end of the month.

## Jim Sharp, Emergency Management Director

- Discussed the current flood event and status of the water levels within the county, road closures due to flooding, and pending severe weather.
- Commissioner Mueller made a motion to declare a state of emergency due to recent floods throughout the County. Commissioner Bass second. All ayes to carry the motion.
