The following proceedings were held:

Invocation given by Commissioner Bass.

Julie Rodgers, Economic Development Director

- Rodgers stated she has been available 24/7 for business community by phone, email, text, and Facebook messenger to help deal with the Covid-19 pandemic. Daily emails/updates to businesses.
- Heavy social media presence with information for businesses in regards to employment questions, SBA and CARES Act.
- Lincoln County Economic Development, Troy Area Chamber of Commerce and Elsberry Community Growth Association have formed a collaboration which includes a business survey, a take-out blitz event, social media-creating a Lincoln County Business Hub on Facebook, establishing a website and putting print ads in the newspapers.
- Discussed day care for essential workers.

Jim Sharp, Emergency Management Director

- Sharp gave a status update for the Covid-19 pandemic in the County. Sadly, the County has had its first fatality due to the virus. Currently there are 24 active cases in the County. Sharp is working with the Lincoln County Health Department and continues to make preparations to deal with the pandemic.
