The following proceedings were held:

Charla Whalen-Mueller, Child Center of Wentzville Board Member**Amy Robins, Child Center of Wentzville Director**

- Discussed the services and programs provided by the Child Center; Requested funds from the American Rescue Plan Act to help provide staffing for an additional advocate, therapist, interviewer and prevention education specialist.
