## Eric Tapley, Highway Department

- Discussed repeated accidents on corner of Penrod and Riverside Roads reported by homeowners the Ryan's. Additional signage has previously been installed on corner but accidents are still occurring. The Commissioners recommended installing rumble strips and have agreed to meet with the Ryan's to discuss further actions that may need to be taken to improve safety.
- Discussed general road maintenance and improvements: Asphalt overlay has been completed on Hampel, N. Cappel, and Chain of Rocks Roads; Lakeview and Sand Hill overlays to begin this week; Asphalt overlays scheduled to begin next week include N. Ethlyn, Argentville, and Mansion Roads, weather permitting.

- Commissioner Bass made a motion to purchase a 11' reversible snowplow for \$8,360.00, and FSH-II salt spreader for \$25,544.00, from Henderson Products, Inc., utilizing Sourcewell Contract# 080818-HPI. Commissioner Mueller second. All ayes to carry the motion.
