- Rodgers presented the economic development activity report on new and ongoing projects.
- Rodgers reported that the request for qualifications for professional engineering services for the design and construction of a water distribution system and a wastewater collection and treatment facility was ready. Commissioner Bass made a motion to issue the RFQ. Commissioner Mueller second. All ayes to carry the motion.

- Stanek and Laws reported on meetings and trainings that they have attended as well as future trainings that are currently being planned.
- Stanek and Laws met with Mike Wood, Prosecuting Attorney, to assist with a Continuity of Operations Plan.
- Stanek has been monitoring developments in the Delta strain of COVID-19 and has made local first responders aware that Emergency Management has some PPE available.
- Stanek gave an update on the HMGP grant projects that were unable to be completed the last time funding was available. Discussion about prioritizing road and bridge projects, tornado sirens, flood gates, and flood plain buyouts. He is preparing a letter of interest to submit to SEMA.
- Stanek has met with the U.S. Army Corp of Engineers to discuss the possibility of revamping the Foley Public Access Boat Ramp.
- Laws attended a FEMA breakdown of the 2020 census data. Lincoln County grew by more than 13% since 2010 to 59,574 residents with a median household income of \$64,196.
