The County Commission convened at 9:00 a.m., pursuant to adjournment on March 1, 2021. The following proceedings were held:

**Julie Rodgers, Economic Development Director**

- Presented Economic Development activity report and updates on ongoing projects and business expansions; assisted numerous small businesses/projects with site searches.
- Rodgers submitted sites to Alliance STL for "Project Dream Green".
- Discussed updates on countywide broadband project.
- Discussed potential and need for an additional entrance to TBHS.

**Jim Sharp, Emergency Management Director**

- Discussed COVID-19 matters; reported on mass vaccination event for second dose.

**Adam Stanek, Floodplain Manager**

- Update on floodplain violations and permits: Four current violations, 155 Guitar Dr., 71 Crenshaw, 753 Paris Branch Rd. and 749 Paris Branch Rd.; Permits, 5 issued.
- Stanek coordinating with Flood Damage Estimator to host an Elevation Certificate & Floodplain Ordinance compliance seminar scheduled for April 6, 2021.

**Sheriff Rick Harrell**

- Sheriff Harrell reported the jail is currently housing 141 total inmates; 71 Marshals.
- Discussed recent transition of administration.
- Discussed the condition and maintenance of Sheriff's Department vehicle fleet.
- Discussed the need to utilize an inventory system for the department.
- Discussed the future of the Re-Entry Program.
- Discussed re-negotiating the federal inmate contract.

- Bids were opened and read aloud from the following for the 2021 Office Supplies: Unipak Corp, Quill LLC, and Office Depot. A bid tab sheet will be completed prior to award.
- Commissioner Mueller made a motion to enter into an MOU with the City of Troy, and the City of Moscow Mills, for the US-61 Outer Road project. Commissioner Bass second. All ayes to carry the motion.
