The County Commission convened at 9:00 a.m., pursuant to adjournment on August 2, 2021. Present: Mike Mueller, Associate Commissioner District 1; Matt Bass, Associate Commissioner District 2; and Taylor Wilmes, Deputy Clerk. Absent: Joseph Kaimann, Presiding Commissioner. The following proceedings were held:

Tessa Bruns, Economic Development

- Presented Economic Development activity report and updates on ongoing projects and business expansions: Submitted a site to AllianceSTL for Project Whiskey; Centerline Properties is working with realtor Greg Schowe on multiple tenant leads for the building on Front Street; Continuing to assist an auto detail shop with site search for a commercial location; Assisting a potential tattoo & t-shirt shop with site search.
- Discussed site visits: Rodgers attended a soft opening for Sweet Butterfly Boutique and an open house for Farmer's Insurance, Rhonda Schulte; Attended a ribbon cutting re-opening ceremony for World League Wrestling.
- Submitted a survey and letter for Northwest Fire Protection District; BRPC is working on a review for the district.

- Lambert reported the jail is currently housing 176 total inmates; 88 marshals.
