The County Commission convened at 9:00 a.m., pursuant to adjournment on August 30, 2022.

The following proceedings were held:

Invocation given by Commissioner Bass.

Adam Stanek, Emergency Management Director**Quentin Laws, Floodplain Administrator**

- Discussed recent trainings attended including G556 Local Damage Assessment and G557 Rapid Needs Assessment.
- Discussed meeting attended for Emergency Weather Reporting; The Lincoln County Health Department has agreed to be an EWR warming center for the upcoming winter season.
- Stanek will be attending an active intruder drill at Winfield R-IV District on September 12th and a first responders meeting with Troy R-III School District on September 21st.
- Laws will be attending training for 414 Critical Infrastructure September 12th – 14th.
- Laws sent a letter to Geeding Farms regarding permitting.

Julie Rodgers, Economic Development Director

- Rodgers presented an activity report for new projects, ongoing projects, and infrastructure: Presented updates on project expansion for Project Tech; Rodgers is organizing a job and career fair with local businesses and Missouri Job Center scheduled for September 15th; Rodgers is assisting BCI with an open house on September 20th; Rodgers reported that the DMV will be re-opening temporarily by the State of Missouri in October; Rodgers reported The Child Center now has a space in Mercy-Lincoln to serve the community of Lincoln County.
- Rodgers passed her MoCED exam while attending the Governor's Conference on Economic Development.

Randy Lambert, Undersheriff

- Lambert reported there are currently 71 federal inmates in the jail.
- Commissioner Bass made a motion to approve the School Resource Officer Agreement between the Lincoln County R-III School District and the Lincoln County Sheriff's Department for the term commencing on June 1, 2022, and expiring May 31, 2023. Commissioner Kaimann second. All ayes to carry the motion.
- Commissioner Bass made a motion to approve the training agreement between employee Blake Stiens and the Lincoln County Sheriff's Department. Commissioner Kaimann second. All ayes to carry the motion.
- Lambert presented a report on the current mutual agreement with the St. Charles County Task Force.
