The following proceedings were held:

Invocation given by Commissioner Bass.

Eric Tapley, Highway Department

- Discussed general road maintenance and improvements: All trucks are hauling rock to various county roads and all graders are operating; Culverts being installed on Linns Mill, Schemmer, S. Willwood, and Reckamp Roads; Crews still widening remaining portion of S. Chantilly Road and installing rock.
- Paperwork has been submitted to MoDOT for approval for Mennemeyer Road bridge replacement, utilizing BRO funds.
- Asphalt patching to begin this week on Pear Tree, Hammett, Brevator, and Thornhill Cemetery Roads.
- Discussed flagging certification for employees.

• General maintenance items and work orders were discussed.

Robert Henebry, Project Coordinator

- Henebry presented his report on current projects: Economic Development Office remodel project is complete. Assembling chairs and moving office this week; Recorder of Deeds office remodel is still under construction. Electricians are in the process of hanging ceiling lights. Carpenters are putting in trim molding and finishing up the windows and doors. Painters are to return at the end of the week to finish up; Demolition project is currently out to bid; Installation of security cameras at Courthouse will be starting in the next couple weeks; Filed rebate with Ameren for lighting in the new Economic Development office and compiled a quote for cost savings and potential rebate if Courthouse lights are replaced.

Commissioner Mueller made a motion to enter into an agreement with St. Charles County for participation in and use of the START Program. Commissioner Bass second. All ayes to carry the motion.
