## THE OCTOBER TERM HELD ON THE 27th DAY OF DECEMBER 2022

The County Commission convened at 9:00 a.m., pursuant to adjournment on December 20, 2022. Present: Joseph Kaimann, Presiding Commissioner; Mike Mueller, Associate Commissioner District 1; Matt Bass, Associate Commissioner District 2; and Mike Kreuger, Chief Deputy Clerk. The following proceedings were held:

# Jessica Zumwalt, Collector of Revenue

• Zumwalt presented tax affidavits for the commission to sign.

## Brenda O'Brien, Treasurer

• O'Brien presented the Sales and Gas Tax Reports for the month of December. O'Brien reports that sales tax was up 7.92% for the month and remains up 3.86% for the year compared to the same period during 2021. Gas tax was up 31.0% for the month and remains up 19.3% for the year compared to the same period during 2021.

### **Budget Hearing**

- Crystal Hall, Budget Officer, presented the following recommendations for budget adjustments to the 2022 Budget:
  - Increase 01-4.520.3.4000 Portal Grant revenue by \$66,917.58. Increase 01-5.520.20200 Contracted Services-Portal Grant by \$65,481.10; Increase 01-5.520.26500 Training and mileage by \$1,436.48. Grant fiscal year renews in September, grant was renewed for fiscal year 2023.
  - Encumber \$144,297.56 from 01-5.504.51000 County Election Cost to cover 01-5.600.52700 Building & Parking Lot Improvements.
  - o Decrease 60-4.531.6.43300 Refunds & Misc. by \$36,000.00 which was misappropriated in the 2022 budget document.
  - o Increase 01-5.533.11850 Crimes Against Children Grant by \$300,000.00. Grant revenues were included in the budget, but the expenses were omitted.
  - o Increase 51-4.541.5.43000 Mennemeyer Rd Bridge by \$10,000.00 to capture revenue for BRO project. Increase 51-5.541.52410 Mennemeyer Rd Bridge by \$26,896.95 to capture BRO project expenses.
  - O Decrease 15-4.531.7.52810 Transfer-LCSO Building Fund by \$1,500,000.00 and increase 15-4.600.7.52810 Transfer-General County Building Fund by \$1,500,000.00. Amount was budgeted for general revenue but only one line item existed at that time. A new line item has been created for the transfer to be correctly executed.
  - O Increase 02-4.541.2.42800 Sales Tax by \$511,0841.54; increase 02-4.541.3.43400 Gas Tax by \$142,311.96; increase 02-5.541.7.42500 Reimbursement-Gas by \$78,979.80; increase 02-4.576.2.42800 ESRD Sales Tax by \$107,715.37; and increase 02-4.576.3.43400 ESRD Gas Tax by \$21,963.64. As a result of the increased revenues, we will increase the following expense lines: increase 02-5.541.20300 Fuel by \$213,845.08; increase 02-5.541.20500 Culvert pipe by \$50,138.65; and increase 02-5.541.22500 Lease/Rental Fees by \$33,380.08.
- Commissioner Mueller made a motion to approve the 2022 budget adjustments as presented by Crystal Hall, Budget Officer. Commissioner Bass second. All ayes to carry the motion.

- Commissioner Mueller made a motion to approve the disposal of asset #8023, Wireless Phone Headset, from the assessor's inventory via recycling. Commissioner Bass second. All ayes to carry the motion to approve the disposal.
- Commissioner Mueller made a motion to approve the disposal of asset #4735, a printer, from the Circuit Clerk's inventory via recycling. Commissioner Bass second. All ayes to carry the motion to approve the disposal.
- Commissioner Mueller made a motion to approve the disposal of the following assets from

  Gauge Shotgun, NT0015A weapon light, NT0037 Mossberg 500 12 Gauge Shotgun,
