The County Commission convened at 9:00 a.m., pursuant to adjournment on August 7, 2023.

The following proceedings were held:

Invocation given by Commissioner Bass.

Eric Tapley, Highway Department

- Road construction projects were placed on hold due to the storms that came through. Crews will continue working on removing trees and debris from roads; Culvert replacements scheduled for Myers Rd and Hammett Rd; All graders are assisting with storm damage removal and will be back to the roads within the week; Asphalt crews are on Kitson Rd followed by Clark Rd. Pug rock operations are scheduled to last a few weeks.
- Discuss Spectrum utility permit requests for the following: HKPT-MO-1-3: Aubuchon Rd, Bohemian Church Rd, Fred Norton Rd, and Gerding Rd.; HKPT-MO-1-4: Delaloye Rd, Country Hill Ln, Giles Rd, N. Rock Church Rd, and Fred Norton Rd; HKPT-MO-1-5: Witt Rd, Prairie Rd, Folta Rd, and White Rd.
- Lincoln County TAC Committee meeting is August 14, 2023, at 2:30pm. Discussion in preparation for upcoming TAC meeting on August 17, 2023.

Robert Henebry, Project Management

- Henebry presented his report on current projects: Discussed current bid review; Reported Sheriff's Department projects including the continuation of painting at CID, Jail lighting fixture repair, and investigation into shower plumbing leak; Highway Department footings have been poured and walls are being set, rock to be added, and electrical line is to be rerouted for gas pumps; Crisis Stabilization Center foundation is complete, backfill and plumbing to begin this week; Justice Center will receive a new picnic table and old tables will be disposed; Assessor's office construction continuing.

- Zumwalt presented her report to the commissioners.


New/Unfinished Business
