The following proceedings were held:

#### Julie Rodgers, Economic Development

• Discussed requests for information that have been submitted; Discussed the status of ongoing projects and business expansions; Discussed various infrastructure activities and industrial site development; and discussed recent and upcoming community events.

# Quentin Laws, Emergency Management Director and Floodplain Administrator

- Laws provided an update on recent trainings and meetings: St. Louis Healthcare
  Coalition (HCC) Medical Collapse Mutual Aid Agreement on February 16, 2024; City of
  Winfield meeting on January 11, 2024; City of Troy meeting on January 18, 2024;
  Jefferson City EMA committee meeting on January 30, 2024; Troy RIII First Responders
  meeting on January 31, 2024; and MODOT future overpass meeting on January 31, 2024.
- Reported on multiple instances of emergency management being called to service, including: the January 18, 2024, electrical grid failure @ N. Lincoln from an auto vs electrical pole collision; the January 19, 2024, train vs car in Winfield, requiring BNSF Hazmat services; the January 23, 2024, ice storm involving 56 reported accidents, including three sheriff's deputies and one ambulance; the January 24, 2024, road closures for water spillage over multiple roadways due to melting ice; the January 24, 2024, chemical spill of 25 gallons of unknown material at Walgreen's in Troy; the January 26, 2024, attempted water rescue in Elsberry; the January 27, 2024, water recovery from the previous day; the January 29, 2024, hospital fire and evacuation at Mercy Hospital Lincoln, involving a malfunction of the HVAC on the roof; and the January 29, 2024, 150 gallon fuel spill reportable at Kroger in Troy, which was cleaned by DNR.
- Floodplain Administration: Will be hosting Spring flood outlook on February 15, 2024, at 6:30 p.m. in Troy High School; the SEMA floodplain bi-annual inspection is on January 22, 2024; and the Army Corps meeting will be held in Elsberry on February 1, 2024.
- Grants received YTD in total \$15,000. Grant was received by the Sheriff's Department for ballistic shields. Upcoming events & miscellaneous items: meeting on a cold case on February 6, 2024; City of Moscow Mills on February 12, 2024; City of Elsberry on February 13, 2024; G288 Local Volunteer and Donations Management class on February 29, 2024; L146 Homeland Security Exercise Evaluation Program on May 13-14, 2024; L105 Public Information and Operations on May 15-17, 2024; and Late Spring/Early Summer all County emergency preparedness exercise with date TBD.

### **Sheriff Rick Harrell**

- Provided department updates: Theft went down in 2023 (with the exception of internet fraud and vehicle thefts); Still waiting on the inmate monitoring bracelets to arrive; the large storage shed is full of items to be auctioned; and budget is looking more favorable for this year over last year.
- Reported there are currently 86 federal inmates housed in the jail: 144 total inmates.
