BALLOT ISSUES
The following issues are to be submitted to the qualified voters of the respective districts at the Municipal General Election to be held in the County of Lincoln, State of Missouri on the 2 nd day of April 2024 as certified to this office.
Lincoln County
PROPOSITION U
Shall the County of Lincoln impose a local use tax at the same rate as the total local sales tax rate, currently one and one-half percent (1.5%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?
Silex R-I School District
PROPOSITION C.A.R.E.
Shall the Board of Education of the Silex R-I School District, Missouri, be authorized to increase the operating tax levy by \$0.4500 to \$3.4955 per one hundred dollars of assessed valuation for the purposes of attracting and retaining quality certified and support staff and meeting additional operating expenses?

(If this proposition is approved, the adjusted operating tax levy of the District is estimated to increase by \$0.4500 from \$3.0455, currently, to \$3.4955 per one hundred dollars of assessed valuation for the 2024 Tax Year and will be applied to the assessed valuation for each year thereafter.)

Elsberry R-II School District

Proposition 2

Shall the Board of Education of the Elsberry R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) for the purpose of providing funds to replace heating, ventilation, and air conditioning (HVAC) infrastructure, flooring, and doors District-wide; to remove carpet and abate asbestos floor tile; to renovate the High School Art & Band Rooms; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.9300 per one hundred dollars of assessed valuation of real and personal property.

Winfield R-IV School District

Proposition Warriors F.A.C.T.S.

Shall the Board of Education of the Winfield R-IV School District, Missouri, with an estimated no tax rate increase in the current debt service property tax levy, borrow money in the amount of Fourteen Million Dollars (\$14,000,000) for the purpose of providing funds for the site development, constructing, equipping, and furnishing of a new Performing Arts Building; to install new heating, ventilation, and air conditioning (HVAC) units District-wide; to renovate the vacant Elementary School including, without limitation, roofs, HVAC, and floors; to complete improvements to the Sports Complex; to the extent funds are available, prepay the existing lease financing and complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.5755 per one hundred dollars of assessed valuation of real and personal property.

Warren County R-III School District

Proposition R3

Shall the Board of Education of the Warren County R-III School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Forty-Five Million Dollars (\$45,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new elementary school and other building additions; to upgrade heating, ventilation, and air conditioning (HVAC) systems; to repair or replace roofing; to acquire land and buildings; to prepay capital facility lease obligations issued to finance construction and capital projects; to the extent funds are available, complete other renovations, repairs and improvements to the existing facilities of the District; and issue general obligation bonds in different years or different amounts as determined to be in the best interest of the District as long as the aggregate amount does not exceed the Forty-Five Million Dollars authorized for the payment thereof?

If such general obligation bonds are issued, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.6503 per one hundred dollars of assessed valuation of real and personal property.

Warrenton Fire Protection District
PROPOSITION LIFE SAVING EQUIPMENT
<p>Shall the Warrenton Fire Protection District borrow money in the amount of ten million dollars for the purposes of decreasing response times to 911 emergency calls and carrying out the mission of the Fire Protection District by improving, equipping and furnishing fire stations and infrastructure in response to increased service demand; purchasing and equipping fire protection and firefighting apparatus, other vehicles, lifesaving medical equipment, and auxiliary equipment; and refunding outstanding lease obligations and issue bonds for the repayment thereof?</p> <p>The authorization of the bonds will authorize the levy and collection of an annual tax in addition to the other taxes provided for by law on all taxable tangible property in the District sufficient to pay the principal of and interest on the bonds as they fall due and to retire the same within twenty years from the date thereof.</p>
PROPOSITION FIRE SAFETY
<p>Shall the Board of Directors of the Warrenton Fire Protection District be authorized to levy an additional tax of not more than twenty-five cents on the one hundred dollars assessed valuation to provide funds for the support of the District?</p>
City of Winfield
PROPOSITON U
<p>Shall the City of Winfield be authorized to impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?</p>
NON-ELECTION DISTRICTS
<p>The following positions have been filled pursuant to Section 115.124.1 RSMo. which states that if the notice of filing provided for in Section 115.127 RSMo. has been published in at least one newspaper of general circulation in the district and the number of candidates who have filed for a particular office is equal to the number of positions in that office to be filled by the election and no ballot measure is placed on the ballot such that a particular political subdivision will owe no proportional election costs if an election is not held, no election shall be held, and the candidates shall assume the responsibilities of their offices at the same time and in the same manner as if they had been elected.</p>
