The County Commission convened at 9:00 a.m., pursuant to adjournment on June 23, 2020. Present: Joseph Kaimann, Presiding Commissioner; Mike Mueller, Associate Commissioner District 1; Matt Bass, Associate Commissioner District 2; and Taylor Wilmes, Deputy Clerk. The following proceedings were held:

Invocation given by Commissioner Bass.

**Eric Tapley, Highway Department**

- Discussed general road maintenance.
- Presented paving updates; Paving completed on Carter and Himmel Roads; Starting base rock on Creech School Road.
- Installing culverts and ditchwork on Robin, Dodson, Walker, Cave Farm, and Spielhagen Roads.

**Maintenance Staff: Randy Siebert, and Bryan Clary**

- General maintenance items and work orders were discussed.
- Commissioner Mueller made a motion to purchase a Kubota RTV-XG850WGL-A from Mordt Tractor, in the amount of \$13,108.73, utilizing GSA Contract# GS-03F-033AA. Commissioner Bass second. All ayes to carry the motion.

**Brenda O'Brien, Treasurer**

- O'Brien presented the Sales and Gas Tax Reports for the month of June. O'Brien reports that sales tax was down 15.1% for the month but remains up 2.6% for the year compared to the same period during 2019. Gas tax was down 29.5% for the month and is down 6.8% for the year compared to the same period during 2019.

**Unfinished/New Business**

- Commissioner Mueller made a motion to approve an emergency procurement to purchase 675 Honeywell North 7700-Series half-mask respirators and 1400 respirator cartridges from Grainger for \$56,648.00. Commissioner Bass second. The ayes carried the motion.
- Commissioner Bass made a motion to enter into an agreement with Community Opportunities to provide public transportation service through The LINC for the term July 1, 2020 to December 31, 2020, in the amount of \$3,512.16. Commissioner Mueller second. All ayes to carry the motion.
- Commissioner Bass made a motion to enter into an agreement with OATS for \$27.50 per hour to provide public transportation services; beginning July 1, 2020 and ending June 30, 2021. Commissioner Mueller second. All ayes to carry the motion.
