The County Commission convened at 10:00 a.m., pursuant to adjournment on May 24, 2021. Present: Joseph Kaimann, Presiding Commissioner; Mike Mueller, Associate Commissioner District 1; Matt Bass, Associate Commissioner District 2; and Taylor Wilmes, Deputy Clerk. The following proceedings were held:

Invocation given by Commissioner Bass.

Sheriff Harrell

- Discussed the need to purchase an additional explorer for Sheriff's patrol fleet.
- Commissioner Bass made a motion to purchase one (1) 2020 Ford Interceptor from Lou Fusz, in the amount of \$34,299.00, utilizing MO Contract# CC1903670002. Commissioner Kaimann second. All ayes to carry the motion.

Eric Maninga, MoDOT

- Discussed list of projects within Lincoln County on the MoDOT STIP.

Brenda O'Brien, Treasurer

- O'Brien presented the Sales and Gas Tax Reports for the month of April. O'Brien reports that sales tax was up 19.7% for the month and remains up 15.1% for the year compared to the same period during 2020. Gas tax was up 43.4% for the month and remains up 6.7% for the year compared to the same period during 2020.

New/Unfinished Business

- Commissioner Mueller made a motion to appoint Adam Stanek as the Lincoln County Emergency Management Director, with a salary of \$45,000.00. Commissioner Bass second.
- Commissioner Bass made a motion to hire Quentin Laws as the Lincoln County Floodplain Manager, with a salary of \$45,000.00, effective June 7, 2021. Commissioner Mueller second. All ayes to carry the motion.
- Commissioner Mueller made a motion to increase Donna Mitchell's salary to \$37,000, effective immediately. Commissioner Bass second. All ayes to carry the motion.

Chuck Billings, County Counsel

- Commissioner Mueller made a motion to enter into closed session to discuss legal matters. Commissioner Bass second. A roll call vote was had. All ayes to enter into closed session. Motion carried.
- Commissioner Bass made a motion to leave closed session. Commissioner Mueller second. A roll call vote was had. All ayes to leave closed session. Motion carried. While in closed session the following vote was had: Commissioner Mueller made a motion to approve the closed session minutes from April 27, 2021. Commissioner Bass second. A roll call vote was had. All ayes to carry the motion.
